ADDENDUM TO ADVERTISEMENT
INVITATION FOR BIDDING

The General Public is hereby informed that the following addendum has been made on the above subject matter, due to the effect of CoVID-19 Pandemic and subsequent lockdown.

2. The OAuGF published an advertisement inviting interested/competent Contractors/Suppliers and Accounting Firms to submit quotation for the supply of goods, works and expression of interest in The Daily Trust, Guardian Newspaper and Federal Tenders Journal on 23rd March 2020. Due to the effect of COVID-19 Pandemic and lockdown, an Addendum in relation to the earlier Advertisement was published in 'The Nation' and 'Daily Trust' Newspapers on the 12th and 13th of May 2020 respectively which extended the deadline for submission of bids to 18th May 2020.
3. In view of the foregoing, to give room for bidders who were unable to submit their bids due to circumstances stemming from the nationwide lockdown, the OAuGF has approved the extension for submission for Expression of Interest as stated below:
