Experiences in using these documents have shown their inadequacies to cater for Large, Complex and Dynamic Procurement of Goods, Works, Services and Administration of contracts arising from their use. Consequently, the Bureau has reviewed and augmented the Procurement Documents and is organizing stakeholders' fora in Four (4) Centres Nationwide in order to receive inputs and reactions from the Public Procurement stakeholders' as scheduled below:
