## Extension of closing date for Online Registration of All Procurement Officers in Federal Procuring Entities (Federal Agencies & Parastatals)

The Circular of August 28th, 2025 with Reference Number BPP/DG/2025/266 refers.

- 2. All **Procurement Officers** in Federal Procuring Entities and other Procuring Entities within the scope of application of Section 15 of the Public Procurement Act, 2007 as amended, are reminded to fill out the Google form which can be accessed via <a href="https://bit.ly/proc-data">https://bit.ly/proc-data</a> with the required details. Also, the **Accounting Officers** (CEs/DGs/Equivalent) of Procuring Entities shall ensure that the Directors of Human Resource fill out the attached form which shall be duly endorsed. **Note that the deadline for submission of all completed forms has been extended to Tuesday, 30th September 2025.**
- 3. Furthermore, Procurement Officers in the Ministries and Non-Pool Procurement Officers currently in procurement Departments and Units are expected to complete the Google Form within the specified deadline; and Directors of Admin/Human Resource should ensure that the abovementioned Officers are also captured in the data form.
- 4. Strict compliance to this directive is strongly advised, as failure may lead to sanctions in line with Public Service Rules and other relevant Federal Government Policies and extant rules. Note that the Bureau will not process any requests submitted beyond the stipulated deadline.
- 5. You are by this circular enjoined to bring to the attention of all concerned Officers.
