INVITATION TO A MEETING WITH THE DIRECTOR-GENERAL, BUREAU OF PUBLIC PROCUREMENT (BPP), WITH ALL PROCUREMENT OFFICERS IN FEDERAL PARASTATALS, AGENCIES AND INSTITUTIONS

The Bureau of Public Procurement (BPP) invites all Procurement Officers serving in Federal Parastatals, Agencies and Institutions to an important meeting with the Director-General, BPP. The meeting is convened to discuss the implementation of the new Procurement Guidelines and the Revised Service-wide Prior Review Monetary Thresholds, as conveyed in the Office of the Secretary to the Government of the Federation (OSGF) Circular of 27th May, 2025, alongside other procurement related matters.

- Since the issuance of the aforementioned circular and the introduction of other recent reforms in procurement processes, the Bureau has received numerous requests for clarification from various procuring entities. This meeting has therefore become necessary to provide comprehensive guidance and ensure uniform understanding and implementation across all Federal Government Procuring Entities.
- The meeting will also address new policy directions, implementation modalities, and the directives of **Mr. President** on the effective management and professionalization of the Procurement Cadre in Parastatals, Agencies and Institutions to ensure efficient procurement processes across all entities.
